Article A. General regulation

1. Rules

Everyone present on the premises is expected to be aware of the regulations and to adhere to them. These rules exist so that everyone can enjoy their holiday.

2. Visitor(s)

Visitors are very welcome. Visitors do not need to be registered, but it is desirable to mention the visit to the owner. Please inform your own visitors of our rules. Your visitors may stay on the premises until 10.00pm. You are responsible for the behavior of you visitor(s). Any car of your visitor can be parked in our general car park. If your visitor has difficulty walking, you can park your own car in the general park in advance, so that your visitors can park at your pitch.

3. Overnight stay

If your vistor(s) wish to stay overnight with you, you must report the visit to the reception or by phone with the owner. This is in connection with the inclusion in our night register, the payment of the overnight rate and local taxes.

4. Use of the pitch

As prescribed by the general regulations of the outdoor recreation permit law (rule 27), permant occupation of camping equipment is prohibited. If this is found, you will receive a warning from us. If you do not respond to this warning, the agreement with you will be terminated with immediate effect and we will immediately deny you access to the campsite. You will not receive a refund and will still owe use the full amount. Young people under the age of 18 travelling alone are not allowed on the campsite.

5. Placing camping equipment

Place your camping equipment on the pitch designated by us. Without our permission, it may not be changed and no changes may be made to or near that spt. We are authorized, if necessary, in our opinion, to move/remove incorrectly placed camping equipment. You must leave the pitch clean and tidy upon departure.

6. Quiet

You are requested to behave quietly, so that your fellow guests are not inconvenienced by you. It must be quiet on the campsite between 23.00PM and 07.00AM. Cars are not allowed to be driven on the campsite.

7. Noise generators

Noise generators such as (portable) radios, televisions, telephones, instruments, etc. must not be audible outside your accommodation. After all, you use these devices for yourself, and not for others.

8. Maintenance work

Due to noise pollution and your own safety, maintenance work is only permitted during the opening hours of the campsite and outside the holiday periods and on Sundays. If you want to carry out maintenance on your pitch outside the opening hours of the campsite, you must make an appointment with us. This way we can ensure that there is always supervision for your and our safety.

9. Traffic

You are allowed to park 1 car at your pitch, other cars must be parked in the communal parking lot.

10. Hygiene

We do our best to make and keep everything as clean as possible. We therefore ask you to leave the premises and the building tidy and not to damage them. If you have any comments or remarks, please report them to reception. This is possible during the current opening hours, so that we can take action. 11. Private sanitary facilities

Our private sanitary facilities receive hot water through a boiler that works on gas. This boiler is connected to a gas bottle. If you experience problems with hot water, you can contact reception during our opening hours. Outside opening hours, you can send a WhatsApp message to Eric Aarsen +31 6 51127805 or Petra Aarsen +31 6 85341889.

12. Maintenance of the grounds

We want to keep the grounds tidy, in the interest of all guests. You must also keep the campsite clean and tidy. This benefits the living environment for everyone. In order to prevent damage to nature, you may not cut down trees or shrubs without permission from the management. The planting must meet the prescribed requirements of the municipality.

13. Waste disposal

Every guest must keep their place free of waste. The various waste containers are located at the recreation area. You must separate the waste, in accordance with the legal requirements. You must remove bulky waste from the campsite yourself!

14. Pets

Your pet is very welcome with us. The dog must not cause any inconvenience to your fellow guests. A maximum of 2 pets may be present per pitch.

15. Gas regulations

Only two gas bottles may be present per pitch. Filling gas bottles is not permitted on the campsite, nor is the use of LPG. The gas installation must be in accordance with the regulations and maintained. This includes your geyser, gas heater and gas hose.

16. Regulations for power connection

The power supply must be in accordance with regulations and maintained. You may only use your own power connection at all times. Abuse will be punished.

17. Fire safety

Be extremely careful with fire and never throw away a burning cigarette or lucifer. Only barbecue fires in the form of coal or gas are permitted. Make sure you have a proper fire extinguisher in your camping equipment. Fire baskets, wood stoves, pallet stoves and open fires are strictly prohibited due to the risk of fire. The consequences can be disastrous.

18. Trading

Offering services and/or goods for sale in any form whatsoever from your camping equipment or elsewhere on the site is not permitted.

19. Complaints

Although we do our best to make your stay as pleasant as possible, you may still have complaints. Please report these to reception as soon as possible so that we can resolve them as best as possible.

20. Sanction

If you do not comply with one of our rules, we will give you a warning. If you do not comply, we can disconnect the utilities to your camping equipment for a certain period of time or terminate the agreement with you. In that case, we can deny you access to our campsite with immediate effect.

Article B. Long-term stay

1. Electricity consumption

The current arrangements and season rates do not include electricity consumption. You pay €0.90 per kWh. You will receive an invoice for this at the end of your camping stay.

2. Maintenance of seasonal pitch

You must carry out the maintenance of your seasonal pitch yourself. You must keep the grass around your camping equipment trimmed yourself.

- a. Digging and/or gardening work is not permitted. This is to prevent possible damage to pipes.
- b. Digging holes and trenches is not permitted due to the underground electricity and water pipes.
- c. Due to aesthetic requirements, we do not consider it acceptable to 'decorate' your camping spot with all kinds of stickers, signs, posters, flags and other indications.
- d. Fences and/or other forms of fencing for pets are only permitted if they are not firmly in the ground and are cleared away after each departure and approved by the management.

When terminating the agreement, you must return the camping spot you have rented clean and ready for use. Selling your camping equipment is only possible in consultation with the takeover of the spot.

3. End of season

At the end of the season, you must leave your spot tidy. Wintering at the campsite is not possible. The spot must be vacated before the end of the camping season. Storing your caravan at the campsite is not possible.
